TO GROUP LEADER

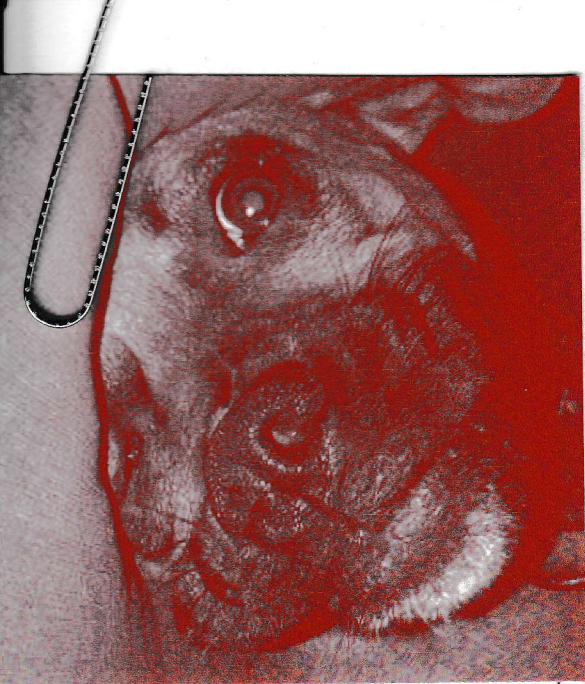
RESOLUTION: GROUP LEADER SPOKE TO INVESTIGATOR'S PARENTS.
